## ACCEPTABLE USE POLICY (AUP)

1. By using our Web hosting services You agree to comply with our policies. 3. You may request (without charge) a printed copy of the Terms & Conditions and/or the policies and procedures applicable to these Terms & Conditions by contacting us a custserv@netwood.net even if you initially accepted an electronic version.

4. Netwood's servers and services may be used only for lawful purposes. Transmission, distribution or storage of any material in violation of any applicable law or regulation is prohibited. This includes – without limitation – material protected by copyright, trademark, trade secret or other intellectual property right used without proper authorization and material that constitutes an illegal threat or violates export control laws. Illegality in any form, including but not limited to activities such as unauthorized distribution of copyrighted software, violation of U.S. export restrictions, harassment, fraud, drug dealing, and other illegal activities. We will be the sole arbiters as to what constitutes a violation of this provision.

5. Netwood makes no warranties or representations of any kind for the services which are being provided. We explicitly disclaim any warranty of merchantability or fitness for a particular purpose whatsoever. We are not responsible for any loss You suffer as a result of using Netwood's services and servers, including but not limited to, loss resulting from delays, improper or incomplete delivery of information, possible computer viruses or interruption of service regardless of cause. Notwithstanding the above, You agree that should Netwood be held liable in a court of law for any action or lack of action related to Your use of Netwood, our liability is limited to the unused portion of Your subscription fee.

6. The provisions of this policy are intended as guidelines and are not meant to be exhaustive. Conduct that violates law and/or regulation whether or not expressly mentioned in this policy, is prohibited. Netwood reserves the right at all times to prohibit activities that damage its commercial reputation and goodwill.

7. Violations of system or network security are prohibited, and may result in criminal and civil liability. Examples include, but are not limited to the following: unauthorized access, use, probe, or scan of a systems security or authentication measures, data or traffic.
